# **Constitution**

1. This Association shall be known as the Tarrant County Baptist Missionary Association.
2. This Association shall be composed of churches, by means of messengers that are members of, and elected by, the church sending them.
3. The officers of this Association shall consist of moderator, assistant moderator, clerk-treasurer, assistant clerk-treasurer.
4. It shall be the duty of this Association on the first day of each annual meeting to elect her officers for the following year.
5. New churches may be admitted to this fellowship on presentation of petitionary letters at the annual session of messengers sent from their church for such purpose, providing that on examination they be found to be in fellowship, in doctrine, faith, and practice with the churches of this Association. The moderator shall extend the right hand of fellowship to the messengers.
6. Each church shall be allowed five messengers.
7. It shall be the duty of the churches of this Association to provide a fund to defray expenses of the Association, including local missions, correspondence, and clerk hire.
8. It shall be the duty of each church in this Association to send a letter annually by her messengers, naming the messengers, the number of members received since the last Association, and how received, number dismissed and how. Also, the amount of funds sent in and for what purpose.
9. This Association shall have no power to lord over the churches, but shall function as an advisory council.
10. In all cases where there is difference between church or individuals of this Association, the same rule shall be observed as taught in Matthew 18 and other Scriptures corresponding therewith.
11. In the event of heresy in doctrine or unscriptural practice on the part of any church of this Association, having come to the notice of the Association, and after the Association has exhausted every scriptural effort to convert the church of the erroneous ways, it shall be the duty of the other churches of the Association to withdraw fellowship from the offending church.

12. This Association shall correspond with other associations of like faith and order as she may direct.
13. All matters coming before the Association shall be determined by will of the majority of the members present, except that of receiving churches, which shall be by unanimous vote. Associations that we correspond with shall be determined by a two-thirds majority.
14. No query shall be received by this Association until it shall have been taken up and elected upon by the church in which it originated. Then if the church fails to get satisfaction, it may be received.
15. This Association shall be governed by regular decorum.
16. As Baptists we do not hesitate to say that as it respects Missionary Institutions, we will not be bound to contribute to any, but will be left to act as the Word of God may lead us to do.
17. This Constitution may be changed, amended or altered at any regular meeting of the Association, by a two-thirds majority of messengers present.
18. This Association endorses the New Hampshire Confession of Faith as a representative compendium of what Baptist have historically believed through the centuries. We refer particularly to the edition in J. E. Cobb's *Church Manual* (third edition), published by the Baptist Publications Committee of Texarkana, Texas.
19. This Association shall meet annually at 9:30 AM on the third Saturday in September at such place as may be designated by the Association in annual session.
20. Newly elected officers shall not take over until the end of the annual meeting.

## **Rules of Decorum**

1. The Association shall be opened with prayer.
2. All officers shall be chosen on the first day of the annual meeting by the messengers present.
3. The moderator shall be considered the judge of order, but any member shall have the right to rise to a point of order as they deem necessary.
4. Any member not satisfied with the moderator's ruling may appeal to the Association for a change on the same day; not later.
5. Only one person may speak at a time, after rising and addressing the moderator and getting recognition, then only shall he speak.
6. The speaker shall not be interrupted until he has given his light, unless he gets out of order, then shall he be called to order.
7. The speaker shall adhere to the subject and in no wise reflect on the ones who have spoken before, by remarking of his failings or the ones who have spoken before, by remarking of his failings or imperfections, but shall strictly present his idea of the matter at hand.
8. No appellation except that of Brother or Sister shall be used in the Association.
9. The names of the members of the Association shall be enrolled by the clerk and called as often as the Association may require.
10. The moderator may not interrupt any messenger, nor prohibit any member from speaking until he has given his light, except he be breaking the rule of the decorum.
11. The moderator shall be entitled to the same privilege of speech as any other provided the chair is filled, but shall not vote unless the Association is equally divided.
12. If any member shall knowingly and willingly break these rules, he or she shall be removed as the Association may think proper, This is to be done on the same day of the offense.

Presently Baptist Missionary Loan Association assets total about \$11.6 million, an increase of \$500,000 in the past year. There are 252 investors with the BMLA: including individuals, churches, local associations and auxiliaries. We appreciate you , and give a big thanks for your faithful support.

Presently we provide loans for 24 projects and have money available to assist more churches with funds to help with their growing ministries. If your church plans to build or buy property, it would be a joy to talk with you about a loan.

### **A BITTER-SWEET YEAR FOR TEXAS BAPTIST HOME FOR CHILDREN**

It is the goal of each public speaker to say something that will have a lasting impact on the listener. Over forty years ago, Rev. C.O. Strong preached at Temple Baptist Church in Marshall, Texas. The basis of his message was a passage in Exodus that relates a time in which Israel was in the wilderness, the people journeyed three days without finding water. They came to Marah, but they could not drink the water because it was bitter- "Marah" means bitter or bitterness. The people grumbled to Moses, "What are we going to drink?" So he cried to the Lord, and the Lord showed him a tree. When he threw it into the water, the water became drinkable. Bro. Strong pointed out that in the Christian life we often have to take the bitter with the sweet. We also know that on occasion God will give us test to see if we really believe what we say. Statements such as, "If you can explain everything that is happening in your Christian life, God is not doing it."

In the last year our ministry has gone through a time of learning to take the bitter with the sweet. The first four months were times of rejoicing as we were impacting the lives of more children than any time in our history. November is recognized as National Adoption Month and we received a foretaste of what would prove to be the year that records would be set through our adoption ministry. Couples and individuals were responding well to accept the challenge to serve as foster or adoptive parents. Churches responded well to the Back-to-School and Christmas appeals. The response to the Change for Children Campaign proved to be another productive year.

On Dec. 17, 2015 a federal judge in Corpus Christi handed down a ruling that would change residential childcare, as we had known it, for many years. The ruling was to call for the closing of all residential group homes. Group homes are homes that provide for more than six children. All six of the campus homes would fall under this regulation. Five of the cottages are equipped to house eight children and one has room for 12. Many of the community homes that contract with the Baptist Home were group homes. Children who were placed in residential care before the December date were allowed to remain in the placement; those who came after that date were moved, some to shelters. In the

final eight months of the year the number of children under the care of this ministry went down from 160 to 112. While this was going on 25 to 30 children are sleeping in CPS offices or where ever space can be found. This affects almost everything concerning our ministry. That is the bitter.

As was mentioned earlier, this was a wonderful year for the Adoption Department as 46 children found a permanent home through adoption . One of the goals of Texas Baptist Home for Children is to see children come to Christ. This year 22 made that all important decision. The Lord has blessed this ministry with the finest staff to be found anywhere. There is a true team spirit. We are blessed to have a great group of loving and nurturing foster families and families who have opened their hearts and homes to make room for a child who desperately needs a home. Our Heavenly Father has answered the prayers of childless couples by placing a baby in their arms.

Many residential child-care agencies have not been able to survive through this crisis. One of the reasons is that they do not have the faithful support of the Southern Baptist of Texas Convention and the Baptist Missionary Association of Texas. Due to your partnership, Texas Baptist Home for Children continues to carry out the mission that the Lord has called it to do, caring for boys and girls who are displaced from their homes and families, and pointing them to Christ and a better future. That is the sweet!

### **CHANGES COMING FOR BAPTIST PROGRESS PUBLISHING SCHEDULE CHANGE AND BUDGET CUTS**

The newspaper industry has seen a lot of changes over the past 15 or so years with the advent of the Internet. The way people communicate has changed drastically with advances in technology-email, texts, websites and more. Newspapers across America have experienced large decreases in their amount of subscriptions, reduced the number of times they publish and some have even closed.

To add to the new way of communicating, paper and postage costs have continued to increase. With the changes in communication and the cost of paper and postage, adjustments have to be made. The old adage is true, "Money doesn't grow on trees."

For the past few years, Baptist Progress has continued with its current publishing scheduling due to funds received by churches that have closed, as well as funds received from the closure of the Baptist Book Center. Such extra income cannot and hopefully will not be depended upon in coming years. We would much rather see our churches thrive than to benefit from the closure of even one.

Therefore, because it is necessary to scale back our budget, Baptist Progress trustees will recommend that Baptist Progress cease printing two 12 page issues per month and begin , printing one quality 16-page paper per month. Of course, those who subscribe by email will still receive news alerts, the Ministry Connection newsletter, e-News Updates and more news.

If you wish to receive up-to-date news, almost as it happens, your best option is to become an email subscriber. Email subscriptions deliver the paper digitally, as it appears in print.

Pastors are urged to lead their church plan subscribers to switch from print to email subscriptions now. Again, current print subscribers may also try the email version of Baptist Progress for free before switching to an email subscription.

Other changes will be made to our budget in order to save money in the 2016-2017 associational year. If approved, changes will become effective following the BMA of Texas Annual Session in November.
